- 22. Payment Terms.
- Marketplace

Since the products displayed on the Marketplace platform are sold, offered and guaranteed by third parties, the invoice must be requested at the time of purchase and will be issued directly by the authorized sellers, which must comply with all applicable regulations.

It is important that the request for the invoice is made at the time the purchase is made or during the current month, after that period can not be issued by the sellers. So we suggest you request it during the confirmation of your purchase. In case you require an invoice for shipping costs, Comercializadora Suarez MOBEE S.A. de C.V. will be the one who issues the corresponding invoice.

#### 15. COUPONS

- The validity of the coupons can not be extended, so it must be used within the validity indicated therein.
- Only one coupon can be used per purchase.
- The delivery, restrictions, use and validity of coupons is specified in each promotion.
